MINUTES FROM THE MARCH MEETINGS

Board Meeting Minutes March 27, 2005

Board Members Present: Val, Sharon, Elaine, Linda, Laura, Sara, Phil, Lou
General Members Present: Al Beers and Sandy Dunaway.

Meeting called to order at 11:43 am.

Motion to approve board meeting minutes from last meeting and as published in the March/April 2005 newsletter. 1st Laura Haupenthal. 2nd Lou Tucker. Passed.

President report – none.

Secretary report – none. Sharon took minutes for the absent Secretary.

Treasurer report – Sara: All accounts have a positive balance. Please contact Sara if you would like details.

Membership – Sara: The 2005 BMDCR Membership Directory is printed and available. Those not picked up at today's meetings will be mailed. Cost for printing the directory was \$145.20. The BMDCR constitution and by-laws are included in the back of the booklet this year.

Renewal applications for 3 sustaining members (Ina Bernard, Jean Gottenborg, and Dean and Margaret Allum) were received after the deadline. **Motion** to accept for sustaining membership. 1st Phil. 2nd Linda. Passed.

AKC License – Sara: AKC has had BMDCR application for 3 months, but not reviewed our constitution and by-laws yet. AKC recently requested current list of members, officers, and activities. Sara will send 2005 Membership Directory and list of activities compiled from newsletters.

Sara also talked to AKC about the geographic area covered by BMDCR. AKC considers this to be the Greater Denver Area from Boulder to Castlerock. AKC requires clubs to have 50% of their voting members residing in the club's geographic area, but voting and sustaining members can reside anywhere; 50% voting members in a club's geographic area

is for AKC accrediting purposes only.

The Board discussed voting versus sustaining membership for out-of-area members. Out-of-area members are only asked to consider meeting attendance and the need to have a quorum of voting members; they are not required to join as sustaining members. Val will address this in the next newsletter.

Draft Test – Lou: Only 3 entries have been received so far for the April 23rd Draft Test. The deadline for entries is April 13th

New Business

Treasurer will submit a financial report (full balance sheet) annually after the end of the fiscal year. Board will review and then it is published during the 3rd quarter of the calendar year. Members may request a financial report from the Treasurer directly at any time.

Reviewed how locations are determined for BernerFiesta and BernerNoel. If more than one member wishes to host, the Board will draw names. Lou and Bob Tucker would like to host BernerFiesta, tentatively on June 26. Laura Haupenthal and Al Beers wish to host BernerNoel, tentatively on December 18th.

Form was received to place an ad in the catalog for the Co. Springs shows in June. It will be passed on to the new Colorado Springs club.

Cost estimates for the BMDCR flag to be provided for the 2005 National Specialty show. Option 1: is a full-color, two-sided flag for \$200. Option 2: is a black-and-white logo on one-side for \$75. **Motion** to select the \$75 option. 1st Linda. 2nd Phil. Passed.

Discussion: Need for written, standing rules pertaining to the Kathy Roth Award, as well as explanation of the award annually in the newsletter when nominations are solicited. Responsibility for accepting nominations and selecting recipient will follow a procedure similar

to that used for the BMDCA outstanding service award. Sandy and Val will draft procedure and standing rule. Christina Ohlsen will be contacted for wording about Kathy Roth since she knew Kathy well.

Val proposed creating a calendar of events and deadlines. She needs a volunteer. Also need to reconstruct centralized documentation of standing rules and committee charters. In addition to a master set of documentation, each committee chairman should receive, maintain, and pass on a notebook of pertinent information, include the committee charter. National committee charters can be used as templates for those that need to be written. Rescue, is one committee with a current charter and written procedures.

All Board Members received a letter dated February 11, 2005 from Cindy Stills on behalf of a group of Bernese Mountain Dog fanciers in the Colorado Springs area. The letter announced intentions to form a new club, tentatively name the Pikes Peak Bernese Mountain Dog Club, to support fanciers in the Colorado Springs area. The letter also expressed a desire to have a positive working relationship with the BMDCR. Representatives of the PPBMDC are scheduled to make a presentation to the BMDCR Board at the May 22nd meeting.

The Board discussed possible short and long-term effects of the new club's formation on BMDCR. It was suggested that Val talk to the Southeast BMDC and the Illinois BMDC since they are experiencing a similar situation. Other suggestions were discussed for smoothing the transition to having more than one BMDC in Colorado, including being proactive about getting volunteers on committees chaired by PPBMDC members so potential new chairmen can be mentored as PPBMDC members become busier with the new club. Overall, it was concluded that BMDCR should continue business as usual and address any problems if and when they come up.

Hospitality – Chairman vacancy. Decided to just ask for volunteers to bring snacks to meetings.

Librarian, Newsletter, Regional Club Council, Rescue, Ways and Means – no reports.

Show News – Val: Denver show results will be in the next newsletter. Dottie Shulte: 2004 new titles will also be in the next newsletter.

Regional Specialty – Sharon: BMDCA and AKC approvals received for 2005 regional specialty, with the exception of pending approval for Clay Coody to judge junior showmanship.

Advertisements submitted for publication in the National Specialty catalog and the Alpenhorn. Working with Evergreen Kennel Club on negotiated hotel rates to be extended to for the specialty day, too. Dottie Shulte: the

Sandy and Val are drafting standing rules for the annual Kathy Roth Award. Members are asked to contact them with any input. Val proposed creating a calendar of events and deadlines (e.g., when a nominating committee has to be formed before elections, when award nominations are due, etc.). Dates need to coordinate with newsletter deadlines. Phil and Dottie volunteered to work on this starting from what Stacy has started. Val also reported on the Board's decision to reconstruct centralized documentation of standing rules and committee charters and how they should be maintained. Val asked about getting the secretary's box of information from past secretary Sharon M.; Sara K. will check to see if Sharon still has anything that has not been passed on to her.

Val described the letter sent to each of the Board members in February regarding formation of a new Bernese Mountain Dog club in the Colorado Springs area. The club is tentatively named the Pike Peak Bernese Mountain Dog Club. Representatives of the PPB-MDC are scheduled to make a presentation to the BMDCR Board at the May 22nd meeting. As always, any member may attend Board meetings to listen to the proceedings.

BMDCR will likely ask for interested volunteers to join committees chaired by PPBMDC members so potential new chairmen can be mentored as PPBMDC members become busier with the new club. Sara Karl pointed out that effect on BMDCR application for AKC accreditation is probably positive because AKC has considered BMDCR's geographic area too large. No changes to membership rules are anticipated, and people can join both clubs if they wish. Overall, BMDCR will continue business as usual and seek to meet the needs of increasing numbers of Bernese Mountain Dog fanciers.

Sandy D. asked if BMDCR would be sending a letter to AKC to protest recent changes in the Canine Good Citizen (CGC) testing program to charge fees to become a certified tester. BMDCR previously responded to this concern by voting to pay member Angela Hanson's certification fee (she will offer testing at the Regional Specialty). It was decided to publish a notice about AKC's change to the CGC program in the BMDCR newsletter as information to the membership. Nadja Torling has a written description that she will give to Val Horney who will add AKC's reasoning for the change.

Phil introduced the program speaker for today: Heidi Elliott. BMDCR will again participate in the Furry Scurry under the corporate sponsor (matching donations) program.
